DELEGATION

At 7:10 pm Mr. Ben Holden addressed Council with questions related to the District's June Newsletter, Mr. Holden asked about the Flood Preparedness Grant from 2013 and questioned why he had not been made aware of the program, he also asked what was included in the \$170,000 spent by the District in 2013 for the potential flood preparedness. Council advised that the bulk of the expense was related to hauling in sand and purchasing sandbags. Mr. Holden requested more information on the proposed Dock Policy, and questioned the additional expenses related to the lagoon expansion as well as the term of the long term loan. Council advised the term of the long term loan is 10 years, however they anticipate with the increase to the municipal taxes the loan will be paid off by 2018.

At 7:30 Mr. Rick Holmes, on behalf of Cedar Villa Estates attended the meeting to thank Council for the remedial work that was undertaken on the internal road of the subdivision. Mr. Holmes asked what the procedure was for lodging a complaint, Council advised that the complaint must be writing to the District Office. Mr. Holmes questioned the 2014 Foreman budget increase, as well as what the Council indemnity expenses were. Administration explained
