Ms. Sherill Wenaus asked what has been going on with Council over recent months. Deputy Mayor Alport spoke of the Boundary Alterations, the Dock Policy, the proposal for selling Municipal Reserve in South Katewpa legally described as Blk/Par MR2-Plan 00SE7838 Ext 0, as described on certificate of Title 00SE0783, Surface Parcel No. 131855126, and the leasing of Right of Ways.

Ms. Wenaus asked what is happening with ROW at Katepwa Street in Sandy Beach. Deputy Mayor Alport advised that the District will be leasing the area in which the building and boathouse are located.

Ms. Weines suggested the District identify another location in the District for an additional public boat launch other than the one located at Sandy Beach as there has been a significant increase of traffic using this boat launch in recent years.



Ms. Karen Behnke asked about the By-Election and if she would be able to set up a booth at the polling place to hand out a questionaire to the rate payers regarding what people would like to see for Breese Park.

Bob Obleman stated his concerns with council decision to lease the Right of Way. Mr. Obleman asked Councillor Thauberger about the public Right of Way located in South Katepwa along Maple Lane in his area and asked who is allowed to use it. Councillor Thauberger advised it is a public access used by the locals in the area.

Councillor Zahorski advised that the District will not be closing the Right of Way adjacent to her property, Council are proposing to close and lease that portion of the ROW where the buildings are located, however there will continue to be public access to the lake at Katepwa Street ROW.

OFFICIAL COMMUNITY PLAN - AMMENDMENTS

CHATTERSON - THAT we do request the following changes be made to the Official Community Plan as per recommendations by the Ministry of Government Relations Community Planning Branch; and further, that we request the Minister waive the requirements for re-advertising the changes.

Sections 1.7.4 Reference Maps: replace the word "resolution" with the word "bylaw" in the second sentence.

Section 3.7.11 Replace the word "Policies" with "Lands" in the title. Delete all of point 3.7.11a. and replace with: "Development of lands subject to flooding shall be prohibited around main water bodies within the District, including all lands which would be flooded by the 1:500 year flood event, or in any flood prone area unless the development is above the elevation representing the 1:500 year return frequency flood event; or,"

Section 3.21 delete "Development will be restricted in the flood plain" and replace with "Development below the 1:500 flood elevation or in the floodway fringe will be prohibited"

Section 3.22 Second sentence delete "Whereby development of a new building or addition is approved" and replace with "but may be permitted upon completion of the appropriate studies and with proper flood proofing measures,".
